Announcements & Public Comment:

- Narendra commended the PA and IHSS for their great work.
- Janie attended a peaceful protest last week in Palo Alto and it was very exciting and very proactive. Joan Baez was in attendance.
 - o Janie also went to the State Capital in Sacramento on June 9th for demonstrations and rallies with multiple people from various nonprofits.
- David mentioned that the Self-Determination Committee is actively seeking new participants.
 David has transitioned to the self-determination program, which is overseen by the Regional
 Center. It is important to safeguard this initiative. He suggested having them speak at a future
 AB Meeting. Reminder: participants must be affiliated with the Regional Center and will need
 to apply and go through their medical insurance to join.
- Joanna is doing well post back surgery and able to drive in three weeks. She canceled the Pre-Planning Meeting for future AB events because she was not feeling well, and she was also concerned with the issues going on in the world: upheaving with ICE raids and violent protests.
- All members discussed the IHSS cuts that were saved in the Senate's bill (no cut to overtime, asset test limit increased); however undocumented individuals would be eligible for IHSS starting Jan 1, 2027. Those with UIS (unsatisfactory immigration status) would be assessed every 6 months.
- Much concern that Federal budget cuts will turn into cuts at the state level, so should be prepared that IHSS consumers will be affected.

Approval of Minutes:

 Motion by Narendra Pathak to approve the May 13, 2025 meeting minutes, seconded by Darcy McCann, vote was unanimous.

Written Reports Submitted:

- Santa Clara Family Health Plan; Social Services-IHSS; Programs & CAPA were distributed via email prior to the meeting and hard copies were also distributed at the meeting.
 - O No reports from CICA or SEIU 2015.

AB Budget for FY 25-26:

- Budget is FLAT.
- Edith showed current areas of budget balances and brainstormed with AB members on items to spend down.
- List of possible items to spend down:
 - June stipends
 - Order more business cards for AB members
 - Submit all travel & mileage reimbursements
 - Purchase a Canopy Tent for outreach activities; see if it could be branded "IHSS Public Authority"
 - o Training from Trudy Gamble (Parents Helping Parents) on Self-Determination
- Edith will share FY25-26 budget with Chair and Vice Chair; was already submitted and is just under \$6K. Once FY25-26 CFL is released, Director will work with Chair and Vice Chair to amend budget. AB allocation request was \$5K so total with match would be just under \$10K.

AB Recommendations for the Annual Report:

• Five high level recommendations were discussed and will be presented and finalized at the next July Board Meeting.

- Discussed strategies for Advisory Board advocacy and storytelling; use cost savings of the program versus nursing home costs. Can the state create a campaign for IHSS, similar to CDA's radio and TV campaigns?

- Edith needs a single document and will submit all requested changes to IHSS and County Counsel after end of the fiscal year.
 - Joanna to send Edith document, discuss in separate meeting.
